#### Understanding Dyslexia

Dyslexia affects an estimated **5–10% of the population**. Like Autism Spectrum Disorder, dyslexia exists on a **spectrum from mild to profound**, and no two individuals present in exactly the same way. It is a **lifelong condition**, cannot be cured, and **is not related to intelligence**. Dyslexia occurs across all levels of ability, socio-economic backgrounds, and cultures, with many individuals of average or above-average intelligence.

Dyslexia is a **specific learning disorder** that primarily affects the processing of written language and, for some individuals, aspects of numeracy. It is recognised under the **Australian Disability Discrimination Act (1992)** and by the **Australian Human Rights Commission**.

Because dyslexia is not visible, it often goes unrecognised. Adults may be labelled as careless, slow, disorganised, or lacking attention when, in reality, they are compensating for difficulties with reading accuracy, written expression, working memory, processing speed, or auditory information.

This lack of recognition frequently leads to:

- Stress and anxiety.
- Reduced confidence and self-esteem
- Ongoing difficulties in study or employment

An appropriate diagnostic assessment often brings **significant changes in understanding and support** from employers, universities, and training organisations.

#### The Assessment

#### Areas assessed:

- Cognitive skills (including working memory, processing speed, sequencing)
- Phonological processing and rapid automatic naming
- Reading, spelling, and written expression

I take a **whole-person approach**, building a detailed profile of how you process information and identifying the underlying causes of difficulty — not just surface symptoms.

- Results and explanations of all assessment tasks
- Clear conclusions
- Practical, tailored recommendations for:
